## 2. Hazards Identification

**Physical state** Liquid.  
**Appearance** Milky white to colored liquid.  
**Emergency overview** CAUTION  
Prolonged or repeated contact may dry skin and cause irritation.

## 4. First Aid Measures

**First aid procedures**

## 6. Accidental Release Measures

## 7. Handling and Storage

**Storage** Store in tightly closed original container in a dry, cool and well-ventilated place. Store away from incompatible materials.
